

Minutes of the Memorial Hall Board of Trustees meeting
Wednesday, April 8, 2020

REMOTE MEETING

The meeting was called to order by Trustee Laura Paladino

Board Members in attendance via roll call: Trustees Laura Paladino, Eric DiNoto, Lou Izzi, and Mike Margolis.

Trustee Paladino opened meeting at 6:01 pm.

Motion made by Trustee Izzi: Accept the minutes of the March 18, 2020 meeting

Seconded by DiNoto. Roll call vote: Trustees Paladino, DiNoto, Izzi, and Margolis, All voted in the affirmative; none opposed; Motion carried

Motion made by Trustee Izzi: To authorize the Executive Director, during any period of time that the Soldiers and Sailors Memorial Building (Memorial Hall) is closed due to the COVID-19 pandemic, to reschedule any and all events canceled immediately prior to and as a result of said closure, subject to availability of Memorial Hall;

AND

To authorize the Executive Director to honor the rental rates set forth in the original rental agreement for said previously canceled event and to apply any payments made by a renter toward the cost of the rescheduled event;

AND

In the event that there is an inability to reschedule a canceled event OR if the renter, for any reason, desires not to reschedule a canceled event and instead requests a refund of any amounts paid in connection with said canceled event, the Executive Director is authorized to take all necessary steps to cause a refund of any amounts paid by said renter, to issue in accordance with the requirements and procedures of the City of Melrose. The request for or issuance of a refund of any amount paid in connection with a rental agreement, shall render said agreement, void and without recourse as to either party.

Seconded by Trustee Margolis. Roll call vote: All voted in the affirmative; none opposed; Motion carried.

Motion made by Trustee Lou Izzi: To authorize the Executive Director to apply motion just enacted to those events up to and including all those scheduled through **August 30, 2020**.

Seconded by DiNoto. Roll call vote: Trustees Paladino, DiNoto, Izzi, and Margolis, All voted in the affirmative; none opposed; Motion carried
